## **COMMITTEE ON ACCESSIBLE TRANSPORTATION (CAT)**

You can make a difference for persons with disabilities riding UTA Services. For more than a decade, the Committee on Accessible Transportation (CAT) has helped improve accessibility on UTA. The CAT has made recommendations ranging from access ramps to audible announcements on UTA Bus, TRAX and FrontRunner, as well as enhanced safety on paratransit, improved wayfinding and more independent securement options on BRT buses.

### **Diversity on CAT**

UTA is seeking a diverse committee representing various disabilities, ages, and geographic areas. Ethnic, racial, linguistic and economic diversity is also important. This diversity is one of the CAT's strengths and means that CAT members have unique perspectives on how to improve rider experiences.

### **Benefits of Being a CAT Member**

Members of the CAT feel great knowing they are part of the process to improve transit services.

CAT members have the opportunity to meet and work with others from the disability community.

### ► Attend Full CAT Meeting

The full CAT meets quarterly during the months of January, April and October, the second Monday of the month and in July for the ADA Anniversary Celebration.

### ► Attend Sub Committee Meetings

Each CAT member will serve on a subcommittee which meets approximately once a month between September and June (about 10 times a year).

### ► Annual Americans with Disabilities Act (ADA) Celebration

As a CAT member, you help plan the annual ADA Celebration, which takes place each year in July to commemorate when the ADA was signed into law in 1990.

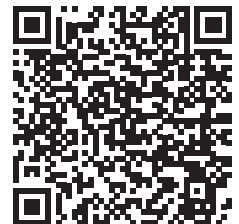
